Position details

The new Post-Doc Researcher is expected to contribute to the Family Business Research Group, and the Department and School of Management more broadly, in the following ways:

- Conducting high-quality research and publishing in top-tier journals in areas such as strategic management, innovation and entrepreneurship, with a special focus on family firms.
- As part of a newly forming team, helping set up the center as a leading platform for rigorous research, forward-looking teaching, effective outreach, and organizational and societal impact.

You have the opportunity:

- To be appointed as a Post-Doc Researcher for up to one to two years to develop your academic career and prepare for a tenure-track position, either at the School of Management of Politecnico di Milano or in other research institutions.
- To work with leading scholars through collaborative research projects on some of the most pressing issues of our times: enhancing the innovative capacity and sustainable competitive advantage of family-owned and managed companies.





- To be part of and guide a dynamic team that is dedicated to top-tier research, inspirational teaching and impactful outreach while fostering a positive working atmosphere.
- To work in a well-equipped, state-of-the-art research infrastructure, with access to some of the world's most renowned businesses for data collection and field research, through the School of Management's network both locally in Milan and globally; as well as a broad range of high-quality databases.
- To be supported in your research and teaching by the School of Management's professional staff members that take on administrative duties, manage our teaching programs, proactively support us in public relations efforts, and run business development activities for our research projects.

Your qualifications include:

- A completed or nearly completed phd degree or its equivalent in Business or Management or neighboring fields, with a special emphasis on family business research.
- A proven publication potential as evident in working papers or submitted papers that are invited for revision.
- Excellent oral and written English, as evidenced in a phd dissertation written in English; Oral and written Italian is a plus.
- A very good understanding of quantitative and/or qualitative research methods, including case study methods, study design and statistical analyses, and a very good command of relevant software packages, such as Stata, and/or SPSS.
- A devotion to writing; experience with popular writing (for outlets such as blogs, magazines, or newspapers) is a plus.
- A willingness to engage with high-profile business leaders and professionals
- Good presentation skills, as evident in conference presentations; teaching experience (ideally with formal student evaluations) is a plus.
- The ability to work in and guide a team; curiosity and discipline, self-reliance and initiative-taking, as well as integrity and creativity.

Terms and applications

Interested candidates should send their expressions of interest to Prof. Josip Kotlar (josip.kotlar@polimi.it). This must include a curriculum vitae, a sample of scholarly work, and the names and contact details of two referees.

To be nominated Post-Doc Researcher in the School of Management of Politecnico di Milano you will be required to formally win a public selection. The indicative timeframe of the process behind the selection is the following:

- a. Collection of Expressions of Interest: October-December 2019
- b. Publication of the notice inviting applications: January 2019
- c. End of the evaluation process: February 2019 (until filled)
- d. If the evaluation is positive, we expect the new Post-Doc Researcher to start from March 2019 or earlier
