

## **Two Assistant professor (tenure track) positions in the department of Business-Society Management**

### **Job description**

Rotterdam School of Management, Erasmus University (RSM) invites applications for two assistant professor (tenure track) positions in the department of Business-Society Management, starting in the spring or fall of 2021, depending on the availability of the selected candidates.

### **Required qualifications**

We are looking for candidates with:

- a PhD in management and organisation or a closely related field (PhD students in their final year are also invited to apply)
- an expertise in management research geared towards addressing important societal and environmental issues
- a strong commitment to high-quality research as well as evidence of ability to conduct impactful work and to publish in top journals
- the ability to contribute to the department's teaching activities at undergraduate, master, MBA, and PhD levels.

### **Employment conditions**

The conditions of employment comply with the collective labour agreement for Dutch Universities (CAO NU). Salary is subject to training and experience and may vary from a minimum of €3,637 gross per month and up to a maximum of €4,978 gross per month (scale 11 CAO NU), based on a full-time contract of 38 hours. Favourable tax agreements may apply to non-Dutch applicants. Erasmus University Rotterdam has attractive employment conditions, which include a holiday allowance of 8 per cent, an end-of-year bonus of 8.3 per cent, and a generous number of vacation days.
