I will recognize several special honorees this year - Rosalie Tung (IM Division Eminent Scholar Award), Eleanor Westney (IM Division Outstanding Service to the Global Community Award), Paul Almeida (IM Division AmorePacific Outstanding Educator Award), and Stav Fainshmidt (IM Division FIU Emerging Scholar Award) - in addition to the winners of the paper and dissertation awards at the IM Division Business Meeting. As I announced in the previous newsletter, in response to the Covid-19 crisis, our division's Executive Committee (EC) launched the division webinar series as a new initiative. In the wake of the COVID-19 pandemic, webinars have become an effective vehicle to help scholars and students around the world keep up with and discuss important topics. We look forward to seeing you at the virtual #AOM 2021 Annual Meeting! The meeting takes place from 30 July to 4 August at: https://21.aom.org/

A major difference in the Program this year is that the PDW and Main Program sessions are intermingled throughout the full program. This led to PDW Chair Grazia Santangelo and I working together to identify themes for each day of the conference and schedule sessions according to these themes. While there are also more general sessions scattered throughout all program days, we believe that the themes will allow for a more focused approach to attending the conference.

AOM 2021 IM Division PDW Program Highlights





Hello IM Division Members!

I am happy to provide details on our 2021 IM Division Virtual PDW Program.

There are several exciting innovations in this year's PDW program. Our PDWs will be primarily "Live" sessions. A separate day is dedicated to the Consortia on Aug 4. PDWs on specific themes are scheduled based on a themed program day allocation. Those on transversal topics, such as research and teaching, have been spread out across the conference program. Let me give you some highlights!

The Consortia day features live sessions that are important to the development of our future division members and leaders. The IM Division "Meet-the-Editors" session led by Ilya Cuypers will open the day (Aug 4, 6:30 – 8:00 am EDT). The session will be followed by the IM Division Doctoral Student Consortium, led by Elizabeth Maitland, and the IM Division Junior Faculty Consortium, led by Jonathan Doh, which will be held in a joint session (Aug 4, 8:00 – 10:00 am EDT, application and pre-registration required). The day will close with two sessions of the IM Division Paper Development Workshop, led by Srividya Jandhyala, scheduled at different times of the day to facilitate participation across time zones (Aug 4, 10:00 – 11:30 am EDT and 9:30 – 11:30 pm EDT), application and pre-registration required).

A second set of sessions focus on **Research and Publishing**. We also have a group of PDW sessions focused on various aspects of **Teaching** and educational programs in the post-COVID era. These include Strategies for successful Virtual or Blended Executive Education Programs post-COVID, led by Carl Fey (Aug 3, 10:00 am – 11:45 am EDT), and What We Have Learned from 2020 for 2030 and Beyond - A Dialogue with senior global executives, led by Gerhard Apfelthaler with the participation of a number of global company executives (July 31, 11:00 am -12:30 pm EDT).

Instead, the PDW on The Role of Multinationals in Tackling Global Sustainability Challenge, led by Stephanie Wang and Vladislav Maksimov (July 31, 8:30 - 10:00 am EDT) will add to the discussion on **CSR & Sustainability**.

We are also a co-sponsor of numerous other PDW sessions with other divisions, so this is just a subset of the total IM Division PDW opportunities available at the conference.

We hope these sessions provide insightful experiences that complement the main conference program organized by William (Bill) Newburry.

Editors' Panel: Data in International Business Research – Sources, Validation & Transparency October 2, 2020 10:00 – 11:30 am (ET)

This is the first of a series of Research Webinars the AOM IM Division organizes.

Recent changes in the international business landscape, such as the rise of the digital economy, nationalistic sentiments across the world, and global pandemics, present researchers with a large set of new questions. Understanding these issues will require new sources of data, beyond well-known databases such as SDC or Compustat. Fortunately, there are new opportunities to build new datasets. For instance, scholars can now use modern programming techniques to gather unstructured data from websites. Several new datasets on a variety of topics such as entrepreneurship, innovation, and emerging economy firms are also becoming available. While these new data sources are critical for advancing research, they also raise concerns. There is little agreement on the criteria for assessing the reliability and validity of new data sources. The increasing use of proprietary datasets also raises challenges with respect to the transparency and replicability of empirical research, as well as inequality of opportunities among research institutes with different resource endowments. The use of the same datasets in multiple papers to investigate different research questions is another contested debate.

This forum is an attempt to look deeper into these important questions about data sources, data validation, and transparency in the domain of international management/business and global strategy. Let's hear from the editors of the field's leading journals! Such a dialogue will be particularly beneficial for PhD students and early-career researchers, as many of them aim at building novel datasets but need guidance in finding the right data sources, assessing their validity for research, and effectively analyzing them in producing high-quality research. The Webinar will begin with a panel discussion, followed by a moderated Q&A for which we invite attendees to share questions of interest.
